The Barbados Medicinal Cannabis Industry allows for eight (8) licenses, all of which will need access to some type, if not total, security solutions, so there are numerous opportunties available for entrepreneurship growth and job creation."

Moore explained the breakdown of the event: "The BAJCAN Connect for Service Providers will be an educational session focused on the industry guidelines under the regulatory framework. We have also invited two experts in the field of security and specifically cannabis security to attend on our panel to speak to everyone. And we've ensure that there will be ample time for discussion and questions."
